- 5 Candidates for Trade Apprentice ( ITI) are required to register in National Apprenticeship Promotion Scheme ( NAPS) portal ([www.apprenticeshipindia.gov.in](http://www.apprenticeshipindia.gov.in))
- 6 Candidates with essentials qualification in regular mode courses are only eligible
- 7 Candidates are requested to bring with them all ORIGINAL TESTIMONIALS including Mark sheets and Certificates and also a Photograph on the date of the interview, failing which their candidature may not be considered. Candidates are also to fulfil medical standards before the training begins.
8. The applicants will be subjected to the short listing by the Selection Team based on the Academic qualification (Marks) and only shortlisted candidates will be called for Offline interview to be held at CSIR-NEIST, Jorhat.
